Valley Oak Academy's main objective is to provide a safe supervised and structured residential setting for boys between the ages of 14-17, who have been diagnosed as emotionally disturbed, Autistic, or have Moderate/ Severe Mental Retardation. There is close contact with Probation, out of area school districts, and the Department of Social Services when a student presents a danger to himself or others. The following agencies are contacted as appropriate: Sacramento County Sheriff's Office (to determine 5150 status), Sacramento County Mental Health Assessment Center, or Juvenile Hall. District officials and parents are contacted when restraints during the instructional day occur. Also, any unsafe behaviors are reflected by both school and residential daily level system.

Valley Oak Academy's main objectives is to provide a safe, supervised and structured residential setting for boys between the ages of 14 and 17, who have been diagnosed as Emotionally Disturbed or Autistic, or have Moderate/Severe Mental Retardation. Valley Oak Academy's ultimate goal is to encourage each client to develop abilities that will allow him to gain a sense of self-worth, increased independence and practical living skills. Our two school sites offer various services including:

- Individualized Education Plans (IEP).
- Behavior Support Plans (BSP)-Writing and Implementation.
- A Full-Time Credentialed Special Education Teacher.
- Four Instructional Aides within the classroom. All of our Instructional Assistants have a B.A. or B.S. degree in a related behavioral science field.
- Small Classroom Ratio 2:1 (Student/ Staff).
- All Staff receive an initial 40 hours of training. Our staff are certified in Professional Assault Crisis Training (Pro-ACT), CPR, First Aid, and are trained in behavior modification.
- In house Licensed Speech Pathologist.

- An on staff registered nurse provides health related services to residents.
- Medical Coordinator to facilitate medical and dental appointments.
- Medication management by Dr. Robert Horst staff psychiatrist/Director of Sacramento County Child & Family Mental Health & Associate Professor of Psychiatry at UC Davis. 95% of our residents require psychotropic medications & receive ongoing consultation with Dr. Horst.
- Our staff includes four licensed MFT's and MFT interns with over 50 years of combined experience. Our therapists are certified by CiMH in Trauma Focused Cognitive Behavioral Therapy, undergoing one year of rigorous training. Clinicians are located on our school site.
- Individually designed therapeutic treatment services.
- Case Management- working with County Placement Workers & Probation Officers.
- Core Curriculum that meets California State and contracting District standards.
- State and District adopted textbooks and supplemental materials.
- Teaching Pro Social Skills (TPS). An evidenced based practice certified by California Institute of Mental Health, provides our clients with components of anger management, skillstreaming, moral reasoning, and communication skills training.
- Level System- Daily Point Sheets where students can work towards privileges and rewards.
- ROP program through Sacramento County Office of Education.
- Career and Vocational planning.
- Competitive year round Sports Teams.

## IX. Student Performance

### Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including:

- **California Standards Tests (CSTs)**, which include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and nine through eleven.
- **California Modified Assessment (CMA)**, an alternate assessment that is based on modified achievement standards in ELA for grades three through eleven; mathematics for grades three through seven, Algebra I, and Geometry; and science in grades five and eight, and Life Science in grade ten. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations.
- **California Alternate Performance Assessment (CAPA)**, includes ELA and mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations.

The assessments under the STAR Program show how well students are doing in relation to the state content standards. On each of these assessments, student scores are reported as performance levels.

Admission requirements for the University of California (UC) follow guidelines set forth in the Master Plan, which requires that the top one-eighth of the state's high school graduates, as well as those transfer students who have successfully completed specified college course work, be eligible for admission to the UC. These requirements are designed to ensure that all eligible students are adequately prepared for University-level work.

Eligibility for admission to the California State University (CSU) is determined by three factors:

- Specific high school courses
- Grades in specified courses and test scores
- Graduation from high school

Some campuses have higher standards for particular majors or students who live outside the local campus area. Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region.
